




TERMS AND CONDITIONS

EVENT ENTRY APPLICATION and DECLARATION

I hereby apply for entry to **Paddle for Patterson** ("Event"). In so applying I **acknowledge and agree** that:

1. **"PPEC"** for the purposes of this application and declaration means Port Phillip EcoCentre, its officers, members, servants or agents.
2. **If accepted I will be permitted** to participate in the Event subject to my complying with the terms and conditions of the Event, this declaration and any reasonable direction issued by the Event organisers or their representatives.
3. **Insurance** is in place that provides limited cover to me whilst I am participating in the Event. I understand that this insurance may not cover me for all injury, loss or damage sustained by me and I can, in my own interests, seek and obtain personal insurances over and above the cover provided by PPEC.
4. **The Event rules and this declaration** comprise a contract between me and PPEC. It is necessary and reasonable for promoting and conducting the Event.
5. **Warning:** Participation in the Event can be inherently dangerous. Risks including but not limited to overexertion, equipment failure, dehydration, serious accident, weather conditions and water quality can and do happen, which may result in me being personally injured or my property being damaged. I have voluntarily read and understood this warning and accept and assume the inherent risks in the Event.
6. **Exclusion of Liability:** Except where provided or required by law and such cannot be excluded, I agree that it is a condition of my entry to the Event (if accepted) that PPEC is absolved from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my participation in the Event.
7. **Release and Indemnity:** In consideration of PPEC accepting my application for entry to the Event I:
 - release and forever discharge PPEC from all Claims that I may have or may have had but for this release arising from or in connection with my participation in the Event; and
 - indemnify and hold harmless PPEC to the extent permitted by law in respect of any Claim by any person including but not only another participant in the Event arising as a result of or in connection with my participation in the Event.

In this **clause 7 "Claims"** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc made by any person entitled to make a claim under a relevant Event insurance policy.



8. **Fitness to Participate:** I declare that I am and must continue to be medically and physically fit and able to participate in the Event. I am not and must not be a danger to myself or to the health and safety of others. I will immediately notify PPEC in writing of any change to my fitness and ability to participate. I understand and will continue to rely upon this declaration as evidence of my fitness and ability to participate.
9. **Medical Treatment:** I consent to receiving any medical treatment considered necessary or desirable for me during my participation in Kayaking Activities. I also agree to reimburse PPEC for any costs or expenses incurred in providing me with medical treatment.
10. **Copyright and right to use image:** I acknowledge and consent to photographs being taken of me by or on behalf of PPEC during my participation in the Event. I acknowledge that the photographs are owned by PPEC and that PPEC may use the photographs for promotional or other purposes without my further consent being obtained. Further, I consent to the Event organisers using my image and likeness in the Event, at any time, to promote the Event by any form of media.
